1. Approval of Minutes of Previous Meeting

2. Treasurer's Report

Tax Return Approved. Accountant report shows assets of \$282,000.00, which does not include a payment to the University of Houston for the HIPLA Institute.

3. Judge's Dinner – Paul Morico

Bob Eury President of Center for Houston's Future is the speaker – non profit Houston downtown focused on making downtown a better place to live. Date is February 22, 2007 at Four Seasons Hotel. Paul sent save the date cards to judges, email went to membership and information was posted on website. Formal invitations will go out the first or second week of January to entire membership.

To do list includes the judges' gifts and the programs printed. Law Firms can make donations and will get name on program.

4. Committee Reports

a. Fall Institute – Steve Koch

There were 242 paid attendees and several comps – over 250 in all. CDs – were successful. The Fall Institute took in a gross of \$135,000.00 including registration and sponsorship. Preliminarily the net is about \$80,000.00. Friday night dinner does not draw enough to make money on. We had 90 paid for dinner and a few comps. Sponsors are already approaching Steve for sponsorships. Thursday night reception is the hot item that sponsors want. HIPLA might consider more than one sponsor or increasing amount for this reception. When we determine the correct amount, we send half to

University of Houston. Moody Gardens called and have 10/3-6 2007 and 9/24-28 2008 reserved, Steve has dates to propose for weekend after the first week in October for 2009. Al Riddle will chair the next HIPLA Institute.

c. Local Rules – Howard Speight

d. Amicus – Sharon Israel

Microsoft v. AT&T case –

Brief will be silent to the issue of damages. It will be an amicus brief that is not in support of either party.

Committee recommended filing brief. Motion to accept recommendation was made by Riddle, seconded by Watkins. Gordon Arnold abstained.

Brief is due December 15, 2006.

Steve Spears moved to provide fellowship to student, seconded by Watkins, accepted unanimously. Paul Morico will invite recipient to Judges Dinner.
